*NHSBA Note, September 2013: RSA 193:12 was again amended, effective 28, 2013, to clarify that pupils to are deemed "legal residents" for school attendance purposes pursuant to a divorce decree or parenting plan filed under RSA 461-A are not entitled to transportation beyond "designated attendance areas for which the child is assigned." This change is reflected in the third full paragraph above.

NHSBA Note, September 2012: RSA 193:12 was amended, effective June 2012, to state "In a divorce decree, or parenting plan developed pursuant to RSA 461-A, a child's legal residence for school attendance purposes may be the school district in which either parent resides, provided the parents agree in writing to the district the child will attend and each parent furnishes a copy of the agreement to the school district in which the parent resides." This policy has been amended to reflect this new statutory language.
